Notice Concerning Property Management Company's Absorption-Type Company Split, and Change in Shareholders and Company Name

New City Residence Investment Corporation ("NCRI") announced that New City Property Services K.K. ("NCPS"), which performs property management services (refers to maintenance and repairs, recommissioning to subcontractors, management of the status of compliance with laws and ordinances, implementation of service programs and all other services relating to lease management services for tenants) for each of the real estate and each of the real estate in trust (excluding Aprile Tarumi) in NCRI's portfolio, handed over the rights and obligations of its property management services (including NCRI's personnel, structure, etc.) to New City Management Services K.K. ("NCMS"), which is a wholly-owned subsidiary of NCPS, as a result of an absorption-type company split, effective April 10, 2009.

In addition, NCRI also announced that NCPS transferred all the NCMS shares it owns to Taisei Housy Co., Ltd. on the same date, making NCMS a wholly-owned subsidiary of Taisei Housy Co., Ltd. and changing the company name of NCMS to Taisei Housy Property Co., Ltd. An overview of the concerned transfer of shares and profile of Taisei Housy Property Co., Ltd. are provided below.

The property management services that NCRI has been entrusting to NCPS will now be performed by Taisei Housy Property Co., Ltd. As Taisei Housy Property Co., Ltd. has taken on the fee and other terms and conditions relating to property management services, as well as NCPS's personnel, structure, etc., there will be no impact on the status of management of NCRI's assets.
